Boxer Puppy Contract

Purchaser (s) accepts full responsibility for proper care of the puppy once it leaves "Besten" Kennels.

Purchaser must have the puppy examined by a licensed veterinarian within 72 hours of delivery and maintain all required vaccinations.

Purchaser must prevent any type of abuse including extended periods of crating without relief, leaving puppy outside with no housing, food or water.

If anytime during the life of this puppy you cannot keep the puppy/dog, the breeder has the right of first refusal to repurchase at fair market price.

If you choose a white boxer it must be kept inside or if outside please place it in a shaded area, white boxers are sun sensitive.

Breeding Rights & Registration

All Besten Boxer puppies will be sold with the AKC Puppy Protection Plan. A fee of \$50.00 paid by PURCHASER which includes AKC Registration and Reunite Microchip & activation. PURCHASER agrees the first word in the puppies AKC registered name shall be BESTEN'S.

If the puppy is not spayed/neutered before leaving the Besten Boxers care, Purchaser will assume all responsibility & risk of spaying, neutering or breeding.

ALL PUPPIES SOLD WITH LIMITED REGISTRATION OR AS PETS ARE REQUIRED TO BE SPAYED/NEUTERED BY 6 MONTHS OF AGE. IF FULL RIGHTS HAVE NOT BEEN PURCHASED THEN THE PURCHASER AGREES THAT THE PUP/ADULT IS NOT TO BE USED FOR BREEDING UNDER ANY CIRCUMSTANCE. NO EXCEPTIONS! PUPPIES/ADULTS FOUND TO BE USED FOR BREEDING WITHOUT HAVING BOUGHT FULL RIGHTS BECOME THE SOLE PROPERTY OF WINNING COLORS LLC OR A MONITARY AMOUNT IS TO BE PAID IN FULL OF \$500.00. PUPPIES/ADULTS THAT ARE NOT OFFERED WITH FULL RIGHTS USUALLY ARE NOT OF BREEDING OR SHOW QUALITY.

ALL PUPPIES SOLD WITH FULL AKC REGISTRATION AND FULL BREEDING RIGHTS ARE REQUIRED TO HAVE FULL VETERINARY HEALTH CERTIFICATIONS INCLUDING HEART, HIP AND THYROID TESTS BEFORE BREEDING. NO EXCEPTIONS! ADULT DOGS FOUND TO BE USED FOR BREEDING WITHOUT THE LISTED HEALTH TESTS WILL BECOME THE SOLE PROPERTY OF WINNING COLORS LLC.

Any dog bred to a BESTEN BOXER's male or female MUST have AKC Confirmation Champions in at least the FIRST THREE Generations of it Pedigree.

Health Guarantee

Your new puppy is guaranteed by the breeder, Besten Boxers for the following conditions:

1. All puppies that are sold will be up to date on vaccinations and de-worming.
2. The Purchaser must have the puppy examined by a licensed veterinarian within 72 hours of arrival. If during the initial exam, should your veterinarian find the puppy to be a poor health risk, you MUST contact the breeder within 24 hours. A diagnosis of coccidiosis, giardia, parasites, kennel cough, or any other type of bacterial infection does not render your puppy unhealthy and breeder is not responsible. Any veterinary bills are the sole responsibility of the new owner; no money will be reimbursed for any veterinary bills.
3. If your puppy is found unhealthy you may elect to keep the puppy, or exchange for one of the same litter (no money back) or a puppy of equal value from a future litter at Winning Colors LLC discretion.
4. If you do not seek a veterinarian within 72 hours the warranty is VOID.
5. It is also guaranteed that the puppy will be free of all deadly and/or crippling genetic disorders for the period of 1 year after purchase.
6. Guarantee is voided in the event of an indeterminable or inconclusive diagnosis. Guarantee does not include any illness due to the ingestion of foreign objects, food, chemicals, or physical injury.
7. Guarantee is also voided if you do not feed the puppy a proper diet.
8. If the dog dies before 1 year of age, the PURCHASER must have pay a necropsy done to ascertain the cause of death at PURCHASER expense.

If one of the above conditions exists within the exception of voids, the breeder will gladly honor its guarantee by replacing the puppy with a new weaned puppy of similar value subject to availability, upon written statement by a certified D.V.M. No money returned. Original puppy must be returned to breeder as well; otherwise no exchange will be made. Buyer may elect to keep the puppy but will be fully responsible for any veterinary bills for this puppy. A certified diagnosis is defined as a positive diagnosis by Veterinary teaching hospital or state licensed D.V.M. acceptable to the breeders own Veterinarian.

Legal Venue

PURCHASER understands this contract fully and agrees this contract is under the legal jurisdiction of the State of Oklahoma, in the County of Cleveland. It is agreed that the legal venue shall be in Cleveland County , Oklahoma.

Purchase Price & Shipping

1. Purchaser agrees to pay \$_____ for the puppy. To be paid in full, plus any shipping cost before the puppy leaves Besten Boxers.
2. Purchaser agrees to pay a **fully refundable deposit** (except buyers' remorse) of \$_____ to hold the puppy until weaned and shipping age.
3. Purchaser agrees to pay all shipping and transportation cost, including Health Certificate and crate for shipping
